<p>Page: Carpool Tags</p>	<p>Why do I need a carpool tag to pick up my student? Carpool tags serve 2 purposes... 1 - Carpool tags are your form of identification and ensure your student is being released to an authorized adult. 2 - Carpool tags assist with efficiently calling students from the building to your car in a timely manner.</p> <p>How do I get a carpool tag? -Two carpool tags are provided to each student's family free of cost at Back to School Orientation AFTER the Carpool Contract is signed. Carpool tags will be available for purchase (\$5) in the front office during business hours, if additional or replacement tags are needed.</p> <p>Can I get more than 2 carpool tags for other friends and family members that pick up my child? -Yes. Additional tags can be purchased in the front office for \$5. Please only share carpool tags with adults that are authorized to pick up your child.</p> <p>What do I do if I don't have my carpool tag at dismissal? -Visit the front office, show your ID so they can ensure you are an authorized adult for pick up, and a temporary tag for the day can be issued. *While we understand this is sometimes an inconvenience, our students' safety is our number one priority.</p> <p>*Please review RCSA Intracoastal's Carpool Contract, as carpool tags will NOT be issued without a signed contract</p>

RCSA Intracoastal Carpool Contract



I, _____ (parent/guardian name), agree to the following conditions/requirements listed below while my child is participating in carpool at River City Science Academy Intracoastal.

- 1.) I will visibly display my carpool tag during afternoon pick up. If I do not have my carpool tag, I will go into the front office and show my ID, and then (a) purchase another carpool tag or (b) wait until the carpool is complete and my child will be sent to the front office for pick-up.
- 2.) When entering the carpool loop, I will pull down as far as possible to the cones or staff members directing traffic, optimizing the number of students that are able to load/unload.
- 3.) I will not pull out of the carpool line and around other cars unless directed to do so by a staff member.
- 4.) I will remain in my car at all times so as not to impede the flow of traffic.
- 5.) When dropping off, my students will be prepared to exit the car in a timely fashion. If my student is not ready to exit the car, I will be directed to park in an allotted space.
- 6.) I will observe a safe and appropriate speed limit in the carpool loop.
- 7.) I will be courteous and respectful to the staff members directing carpool and safety patrols assisting students.
- 8.) If I am a walker, I understand that I must wait until the carpool is complete before my child will be released.

Failure to comply with any of the above requirements may result in my carpool privileges being revoked. I have read the carpool procedures and will adhere to the conditions and requirements in order to keep the students, faculty, and staff safe at River City Science Academy Intracoastal.
